Type Rating Prerequisites – As a minimum, pilots must hold a private pilot certificate or commercial pilot certificate, a multi engine and instrument rating with 1000 hours total time for the CL 65 Type Rating.

ATP Prerequisites – FlightSafety is able to administer Airline Transport Certificate (ATP) Checks during the Pilot Initial and Prior Experience Course. To qualify, pilots must meet the appropriate requirements of 14 CFR Part 61.153.

Prior Experience Course – This course is designed for pilots who are seeking an additional type rating, or the addition of an ATP. This course is also for those pilots who have been flying the aircraft as SIC and now want to obtain a Type Rating. These pilots must have completed an FAA approved pilot initial course and meet the type rating prerequisites.

Simulator Training for Crews - If training as part of a crew, clients will receive an equal amount of pilot monitoring time in the simulator. Total hours in Initial Course will be 32, total hours in Prior Experience Course will be 16, and total hours in Recurrent Course will be 12.

Simulator Training for Clients attending alone – If training is not conducted as part of a crew, the client will receive Pilot Flying time in the simulator. Total hours in Initial Course will be 16, total hours in Prior Experience will be 16 (includes 8 hours pilot monitoring time), and total hours in Recurrent Course will be 6.

Second Crewmember Training - Pilot training that requires FlightSafety to provide a second crewmember will be charged an additional hourly rate per simulator hour.

Training Materials – Training and Pre-Course Study materials are available electronically to clients 60 days prior to scheduled training via FlightBag, our second-generation training materials app. Materials are updated automatically as new information becomes available, yet keeps all of your previous notes. The FlightBag App is available on iTunes for free.

Maintenance Training – Maintenance Training is also available for this aircraft.
