Initial training covers use of OEM documentation, component location, normal operation, inspection, service and repair of aircraft systems.

Course participants will be able to demonstrate proper interpretation and utilization of technical data as well as recall major system and sub-system normal operations, safety precautions, ground handling, and system test procedures. The Initial training programs are aligned with FAA, EASA, TC, CASA, and CAAC requirements, as applicable.
